Objective:

The objectives of the Committee are:

- Prevent discrimination and Sexual harassment against women, by promoting gender amity among students and employees;
- Deal with cases of discrimination and Sexual harassment against women, in a time bound manner, aiming at ensuring support services to the victimized and termination of the harassment.
- Recommend appropriate punitive action against the guilty to the Principal.

Procedure for Approaching Committee:

The Committee deals with issues relating to Sexual harassment at SHREE KRISHNA INTERNATIONAL SCHOOL. It is applicable to all students, staff and faculty. A complaint of discrimination or Sexual harassment may be lodged by the victim or a third party. A written complaint may be addressed to the Convener of the Committee. If the complaint is made to any of the Committee members, they may forward it to the Convener of the Committee Against Sexual Harassment. Here it should be noted that according to the Supreme Court Guideline Sexual harassment can be defined as "unwelcome" Sexually determined behaviour (whether directly or by implication) as:

- Physical contact and advances
- Demand or request for Sexual favours
- Anti-Sexually coloured remarks
- Showing derogatory picture
- ❖ Other unwelcome physical, verbs or non-verbal conduct of a Sexual nature.

The following is also Sexual harassment and is covered by the committee:

- Eve teasing
- Unsavoury remarks,
- ❖ Jokes causing or likely to cause awkwardness or embarrassment,
- Innuendos and taunts,
- Gender based insults or sexist remarks,
- Touching or brushing against any part of the body and the like,
