1. This Proposal has been filed by applicant school to determine fees for the year 2024 - 25, 2025 - 26 & 2026 - 27.
2. Applicant school is affiliated with CBSE Board.
3. School is English medium school.
4. School is situated at. Kalwada - Pitha Road, Kalwada, Valsad - 396045.
5. This Proposal is for P. P. To 10.
6. This school is registered with 24250105803 U - dis number.
7. School has filed this proposal on 27-10-2023 to determine fees for the year 2024 - 25, 2025 - 26 & 2026 - 27.
8. We have gone through the papers submitted along with proposal. It appears that school has produced accounts for the year 2019 - 20, 2020 - 21 & 2021 - 22. It appears that school is collected term fees in addition to tuition fees. Whether fees proposed includes term fees or not is required to verify. We have verified the audited accounts. It appears that strength of students is 263.
9. After perusing the documents, this committee has passed order of provisional fees on 21/03/2024. Being aggrieved by the said order school has filed its objection on 18/04/2024. This committee wrote a letter to the school for personal hearing and also

asked for some documents. On 23/04/2024 Preeti Mundra, Trustee of the school appeared before the committee and hearing was conducted.

10. During hearing it is submitted by the authorized person of the school that 10% increase for the year 2024-25 and 8% increase for next two years if allowed, they shall not charge any extra fees including term fees.

11. As per observation made by the Hon'able High Court in Special Civil Application No. 2352/2021 self-financed schools may charge Two months fees as term fees in addition to fees determine by the FRC. considering the above facts in mind and undertaking given by the authorized persons of the school we determine fees as under:


