2	Proper signage to be fixed at the entrance of toilets and submit the compliance through a videography within 3 months on SARAS portal.
3	The school has commenced the work of installation of lift to access upper floors. The school is required to submit the compliance after the installation through a videography on the SARAS portal within 3 months.
4	The school has improved the Composite Science lab. However more hand wash basins are needed. Only 1 small sink is shown which may be inadequate. The school shall upgrade the lab as per SoP issued by the Board within 3 months and submit compliance on SARAS.
5	The ramp at the school entrance to be aligned with the road level. This modification will facilitate easy access, and a supporting railing to be installed to ensure additional safety and assistance for CWSN and submit the compliance within 3 months on SARAS portal.
6	The school shall ensure the training of its teachers with CoE Ajmer within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal.
